

# Minutes of the Annual Meeting of Members (AMM) of Ontario Basketball (OBA) Held Virtually on Saturday, November 7, 2020

## Approved at the 2021 Annual Meeting of Members (11.13.2021)

#### 1. Call to Order (Parliamentarian)

The meeting was called to order by Parliamentarian Bob Borden at 11:05 a.m. who then chaired the meeting.

## 2. Opening Remarks (*President*)

Stephanie Rudnick thanked the membership for enduring through the challenges related to Covid and acknowledged an active meeting based on members registering.

Additionally, David Coulthard recognized Erica Gavel for being part of the Board of Directors for four years and Barbara Capes recognized Stephanie Rudnick serving as part of the Board of Directors for six years.

### 3. Appointment of Scrutineers (Parliamentarian)

Mike Barbin and Jason Jansson were appointed as scrutineers.

#### 4. Report of Scrutineers (Parliamentarian)

Following a test vote by Data On The Spot, the scrutineers reported that there were 148 votes in the room.

#### 6. Minutes of Last Meeting – Annual Meeting of Members (November 9, 2019)

The members were asked to review the minutes of the 2019 AMM and bring any corrections forward. With no corrections brought forward for the 2018 AMM minutes, the minutes were deemed by the Chair of the meeting to be approved as printed.

## 8. Board & Staff Reports

#### **Ontario Basketball Annual Report**

Jason Jansson highlighted that prior to the provincial shutdown due to Covid-19 in March 2020, OBA was projected to have its most successful year to date with record revenue generation and program / activity output. Unfortunately, all Ontario Basketball events, programs and activities from March 13 until August 31, 2020 were cancelled. Jason Jansson thanked OBA staff and Board of Directors for their commitment to the organization. Jason then announced that OBA's 2019-20 Annual Report, which summarizes the organization's activities for the past fiscal year, was posted to the Ontario Basketball website on Thursday, November 5, 2020. #### 9. Report of the Auditors

#### **Ontario Basketball Finance Report**

The OBA staff answered questions related to the current status of member clubs across the province, the status of basketball in Ontario for January 2021, the mandate of the Gyms for Kids Committee and whether there will be plans for other ancillary programs (such as Ontario Summer Development Program, etc.) in 2020-21.

Stephanie Rudnick (President) welcomed the newly elected and re-elected Board members. Also, Stephanie thanked the Board, staff and membership for their tireless efforts and highlighted the opportunity to be part of and serve Ontario Basketball for the past six years as a Board member.
