Dear Active Member/Affiliate Member/Honourary Member (“Voting Member”):

This document is Ontario Basketball’s (OBA) Ballot/Proxy provided for the use of Voting Members at the Annual Meeting of Members (AMM). The Ballot/Proxy is accompanied by a circular containing information about the Annual Meeting of Members. The corporate governance is scheduled to take place on Saturday, February 25, 2023 at 11:00 a.m. virtually via GoToMeeting & ElectionBuddy.

This document contains your Ballot and your Proxy for the purposes of:

- Electing directors for the Board of Ontario Basketball;
- Appointing auditors for the Association;
- Voting on OBA business and motions that may properly come before the AMM.

Voter Eligibility:

Eligible voters for this ballot will include anyone who is 18+ and paid dues as an active member of Ontario Basketball between September 1, 2021 and February 3, 2023.

Voting Instructions

In consideration of the health and safety of its membership, Ontario Basketball is hosting the 2020 AMM virtually. While the most efficient way to exercise a vote is to register for and attend the virtual AMM, Ontario Basketball is providing additional options by email and mail.

Option 1 – Attend the Virtual AMM. Register via Eventbrite.

Option 2 – By email in advance of AMM:

- a) Print, fully complete, sign and date the Ballot (page 2) and e-mail it to communications@basketball.on.ca at least 48 hours in advance (excluding any part of a day that is not a business day) of the AMM.
- b) Print, fully complete, sign and date the Proxy form (page 3) and e-mail it to communications@basketball.on.ca at least 48 hours in advance (excluding any part of a day that is not a business day) of the AMM

Option 3 – By regular mail in advance of AMM:

- a) Print, fully complete, sign and date the Ballot (page 2) and mail it to Ontario Basketball, 55 Gordon Street, Suite 2A, Whitby, ON, L1N 0J2: Attention Dave Stockton so that it is received at the office at least 48 hours in advance (excluding any part of a day that is not a business day) of the AMM.
- b) Print, fully complete, sign and date the Proxy form (page 3) and mail it to Ontario Basketball, 55 Gordon Street, Suite 2A, Whitby, ON, L1N 0J2: Attention Dave Stockton so that it is received at the office at least 48 hours in advance (excluding any part of a day that is not a business day) of the AMM.

Please note that if you vote prior to the meeting using a valid Ballot/Proxy, and also register for and attend the AMM, your Ballot/Proxy will be acted on by the scrutineer.
